

WHEREAS, the Annual Budget for the Township of Parsippany-Troy Hills Fire District No. 2 (the "Fire District") for the fiscal year beginning January 1, 2017 and ending December 31, 2017 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 12, 2016; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$322,000.00, which includes an amount to be raised by taxation of \$322,000.00, and Total Appropriations of \$322,000.00; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 14, 2016 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2017 and ending December 31, 2017 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and





*The Fire District proposes an Annual Budget of \$322,000.00 for 2017 compared to 310,000.00 for 2016. The significant changes in this year's Budget are for Insurance and Promotion.*

*The District's Amount to be Raised by Taxation will increase from \$285,500 in 2016 to \$322,000 in 2017 and its use of Unrestricted Fund Balance will be \$2,329.00 compared to the \$24,500 used in 2016. The use of Unrestricted Fund Balance was previously used to help offset the Tax rate which is going up due to the loss of ratables. The projected tax rate will increase from 4 point 4 cents per \$100 of assessed valuation to 4 point 9 cents per \$100 of assessed valuation.*


