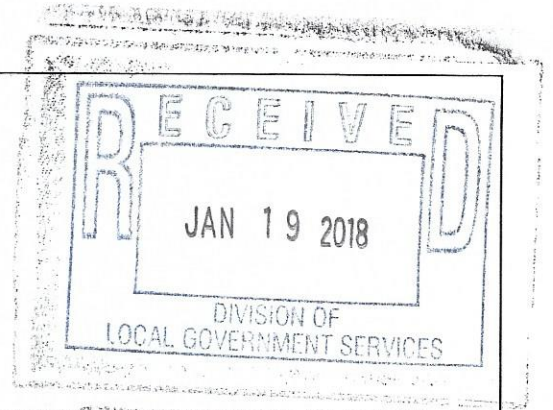



WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$337,910.00, which includes an amount to be raised by taxation of \$327,910.00, and Total Appropriations of \$437,910.00; and



WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;



WHEREAS, the adopted budget is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and



The Fire District proposes an Annual Budget of \$437,910.00 for 2018 compared to 322,000.00 for 2017. The significant changes in this year's Budget is for Building Improvements in the Capital Appropriations section.

2. Complete a brief statement on the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation to support the district budget and on the Restricted and Unrestricted Fund Balance(s). Explain increases or decreases in the tax rate and utilization of fund balances. If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The District's Amount to be Raised by Taxation will increase from \$319,671 in 2017 to \$327,910 in 2018 and its use of Unrestricted Fund Balance will be \$110,000.00 compared to the \$2,329 used in 2017. The use of Unrestricted Fund Balance is being used to pay for needed building repairs. The projected tax rate will remain unchanged at 5 point 0 cents per \$100 of assessed valuation.

3. Include a statement explaining how the Fire District is complying with the Property Tax Levy Cap. The statement must explain reasons for exceeding the Levy Cap and identify the appropriations that caused the Fire District to exceed the Levy Cap, and how they are being addressed by a referendum.

The District is within the 2% maximum cap levy restriction.

4. If the Fire District plans to pass a Resolution for the Release of Restricted Fund Balance, explain the reason and purposes of the appropriation.

The District is budgeting \$95,000 for Future Capital Outlays in 2018 the same as in 2017. It is also budgeting \$110,000.00 to do some needed building repairs.
