WHEREAS, the Annual Budget for the Township of Parsippany-Troy Hills Fire District No. 2 (the "Fire District") for the fiscal year beginning January 1, 2019 and ending December 31, 2019 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 10, 2018; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,014,468 which includes an amount to be raised by taxation of \$584,468, and Total Appropriations of \$1,014,468; and







The Fire District proposes an Annual Budget of \$1,014,468 for 2019 compared to \$437,910 for 2018. The significant changes in this year's budget are for the purchase of a fire truck and building improvements.

2. Complete a brief statement on the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation to support the district budget and on the Restricted and Unrestricted Fund Balance(s). Explain increases or decreases in the tax rate and utilization of fund balances. If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The District's Amount to be Raised by Taxation will increase from \$327,910 in 2018 to \$584,468 in 2019 and its use of Unrestricted Fund Balance will be \$430,000 compared to \$110,000 used in 2018. The use of Unrestricted Fund Balance is being used to pay for most of the purchase of the fire truck. The projected tax rate will increase to 9.0 cents per \$100 of assessed valuation from 5 cents, a 4.0 cent increase.

3. Include a statement explaining how the Fire District is complying with the Property Tax Levy Cap. The statement must explain reasons for exceeding the Levy Cap and identify the appropriations that caused the Fire District to exceed the Levy Cap, and how they are being addressed by a referendum.

The District is within the 2% maximum cap levy restriction.

4. If the Fire District plans to pass a Resolution for the Release of Restricted Fund Balance, explain the reason and purposes of the appropriation.

This is not applicable for 2019.

5. Complete a brief statement on the Annual Budget's proposed capital appropriations and payment methods, including debt service for the proposed budget year and for future years.

The District is budgeting \$95,000 for Future Capital Outlays in 2019, the same as in 2018. It is also budgeting \$30,000 to do some needed building repairs and \$650,000 for the purchase of a fire truck and apparatus.
