Charles Iantosca, Commissioner	\$3,500.00; and

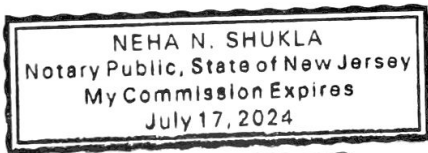

This Resolution shall take effect immediately.


